- ▶ Load conveniently: Via another credit card, bank transfer or using cash at one of over 20,000 e-va terminals

## MULTITIERED REGISTRATION AND LEGITIMATION PROCESS: PRODUCT LIMITS OF mywirecard 2go Visa

**The following tiers have been implemented in accordance with applicable law (e-money directive, 2000/46 EC):**

- ▶ Tier I "Anonymous": The consumer can load a card with a maximum of € 150
- ▶ Tier II "Registered": After completing online registration, the consumer can load the card with up to € 2,500 p.a.
- ▶ Tier III "Legitimated": Once the amount loaded or the amount transferred by a third party exceeds € 2,500, identification in accordance with applicable German law (sec 154 German Tax Code and secs 1 and 2 German Money Laundering Act) is required
